Changing Environment of Quality Assurance

- Revised Standards and Guidelines going to Ministers for approval in Yerevan, Armenia in May 2015
- All full members of ENQA have undergone external review, many for the 2nd time – question of added value
- Agencies have merged in Austria (3); Belgium-FL (2); Ireland (3)
- ENQA is publishing all reports and decisions (accept, re-confirm, under review, reject)

Changing Environment of Quality Assurance

- ENQA is not the only body co-ordinating external reviews of agencies
- A number of agencies have become full members (under review)
- Increased convergence of ENQA membership and EQAR listing
- Some agencies listed on EQAR are not ENQA members (and vice versa)
- A number of national agencies have conducted evaluations outside their own jurisdiction

ENQA Facts (October 2014)

- 43 full member agencies (including 2 members under review)
- 32 affiliates

In terms of representation throughout the 48 systems in the EHEA:

- 23 countries have agencies that are full members of ENQA
- 2 countries have agencies that are full members (under review) of ENQA
- 15 countries have agencies as affiliates
- 8 countries are not represented by either a full member or an affiliate

Current Strategic Plan (2011-15)

Current Strategic Plan expires in 2015

It is best represented by its **3 Purposes**:

- To represent its members
- To function as a think tank
- To function as a communication platform

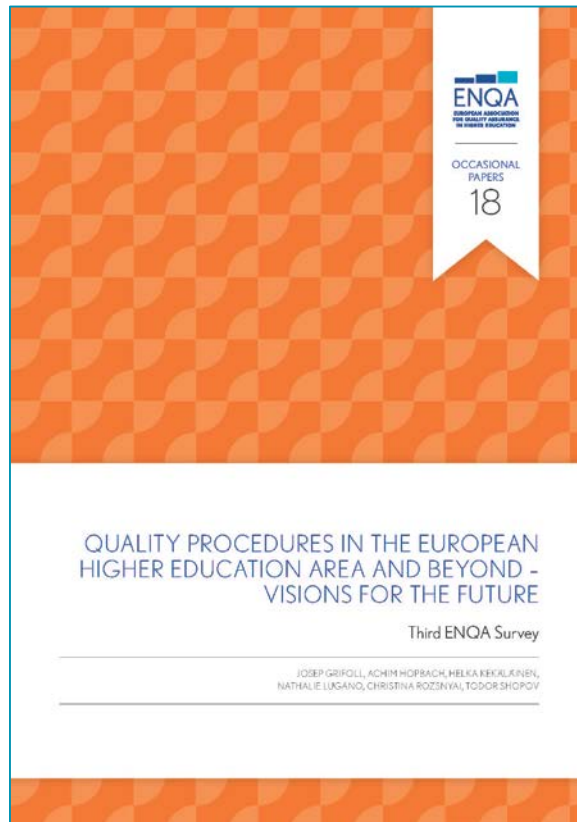
Organise Seminars, Workshops, Events for Member Agencies

Over the period of the current Strategy, ENQA has organised (or co-organised)

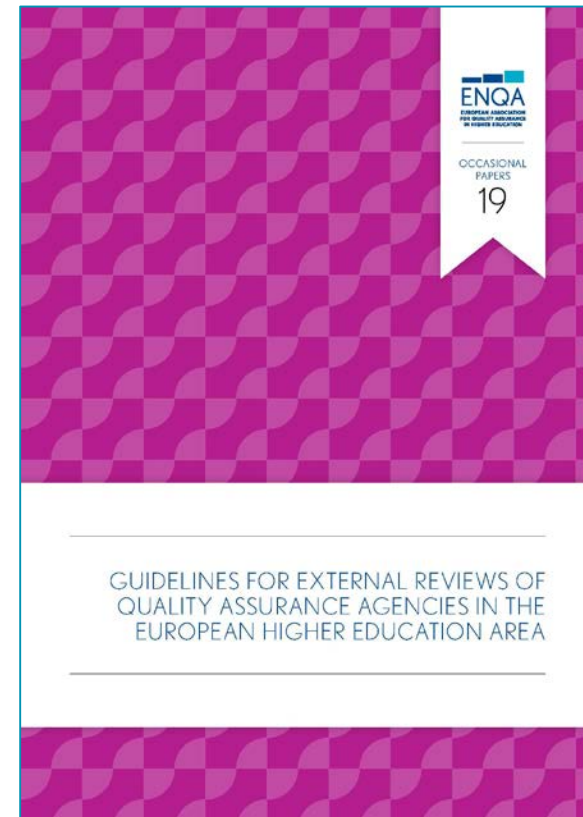
- 19 Seminars/Workshops

3rd Quality Procedures Survey (2012)

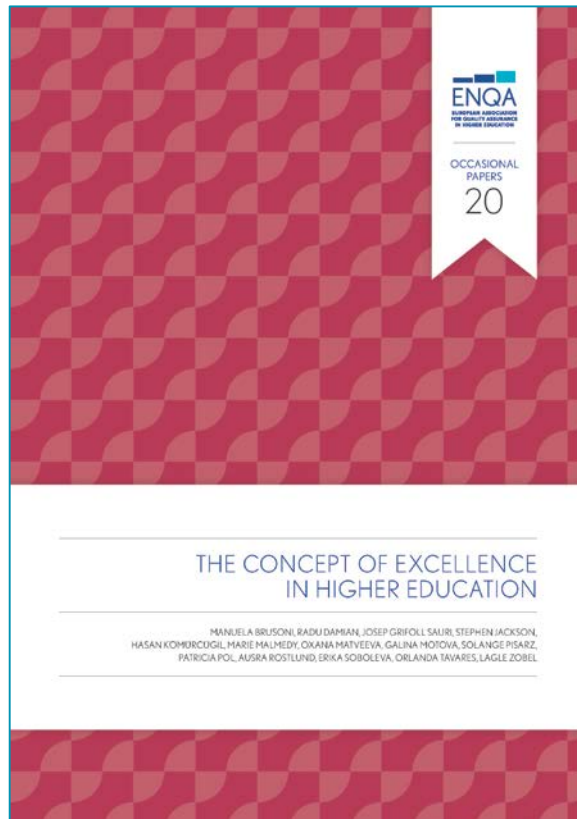


External Reviews of QA Agencies (2012)

Organise Reviews and Scrutinise Review Reports of Member Agencies

- 2014 (to date) (Decisions taken on 12 review reports (12 ENQA-organised))
- 2013 (Decisions taken on 8 review reports (7 ENQA-organised))
- 2012 (Decisions taken on 7 review reports (4 ENQA-organised))
- 2011 (decisions taken on 5 review reports (4 ENQA-organised))

Path for new Strategy 2016-2020

- February 2014 – outline for developing new Strategy approved at Board Meeting in Barcelona
- March 2014 – Strategy sub-group meets in Brussels to develop proposal for discussion at Members' Forum
- April 2014 – priorities for Strategy discussed at Members' Forum in St. Petersburg
- June 2014- Strategy away day for ENQA Board (following Board Meeting in Madrid)

Path for new Strategy 2016-2020

- August 2014 – Strategy sub-group meets in Brussels to prepare draft Vision, Mission and Values
- September 2014 – draft Vision, Mission and Values discussed at Board Meeting in Rome
- **October 2014 – Draft outline for Strategy discussed at General Assembly in Zagreb**
- April 2015 – Draft of full Strategic Plan for discussion at Members' Forum in Seville
- October 2015 – Strategic Plan presentation for ratification at General Assembly in Dublin
